- A full report which documented the results of an investigation and/or secondary analysis of existing data reporting the aim of the investigation, method, findings and conclusions and/or recommendations
- At least one aim of the study related to people with disability.
- Disability research including <u>Australian participants/topics</u> and reporting results on those participants/topics. This included
 international comparative studies. 'Topics' included in order to capture studies such as those about Australian disability policy,
 social context and services, where there were no participants.
- The results developed conclusions related to people with disability.

Exclusion criteria

- Not publicly available
- Not written in English.
- Does not contain any original research paper (e.g., commentaries, viewpoints, policy cubmissions which do not contain research).
- Disability discussed is acute and/or transient (an excluded study would be on rehabilitation from an acute injury such as short-term limb dysfunction after a fracture).
- Research which was primarily lab-based and related to genetics, <u>treatment</u>, diagnosis or cure (e.g., "medical prevention and cure", surgical or clinical) which did not also consider the broader functioning, disability, health and wellbeing of people with disability.
- The aims of the report did not relate to people with disability or disability is mentioned only in passing.
